CALL TO ORDER/QUORUM:

The meeting was called to order at 9:21 a.m. The Agenda was adopted as presented.

MINUTES:

The Minutes of the Board of Directors Meeting held on May 14, 2020 were presented to the Board for approval. A motion was made by Katz to approve the minutes and seconded By Levan. The motion carried and the minutes were approved unanimously.

Proposed Change by Fire Board: Illuminate #'s 1 & 2. Add; When the Fire Board is in a position to hire a new Fire Chief, The Fire Board President will form a "Fire Chief Search Committee" comprised of (1) member selected by the members of the Volunteer membership, (1) member selected by the current members of the Duty Crew membership and (3) Fire Board Members appointed by the Board President. Once the Search Committee has completed its review process, the Search Committee will provide a list of at least 3 to 5 qualified candidates to the Board President. At such time, the entire Fire Board will then conduct final interviews of the candidates provided by the Search Committee and choose a final candidate from the list provided.

- 1. Article V. Department Officers Section 5. Eligibility for elective and appointed officers:
 - D. Training Officer
 - 1. Member in good standing for two (2) consecutive years just prior to appointment.

Proposed Change: Remove D. Is now a Captain position.

Katz made a motion to approve the revision as presented and Levan seconded the motion. After discussion, the motion passed unanimously.

- 2. Article V. Department Officers Section 5. Eligibility for elective and appointed officers:
 - G. Safety Officer
 - 1. Member in good standing for two (2) consecutive years just prior to election.
 - 2. Completion of NFPA Safety Officer Training course.

Proposed Change: Remove G. No longer officer rank.

Katz made a motion to approve the revision as presented and Levan seconded the motion. After discussion, the motion passed unanimously.

- 3. Article IX. Duties of Officers Section 1. Chief.
 - A. The Chief shall command the Department at all fires, drills or other Department activities, and shall enforce a strict performance of duty of the membership as described in the Constitution and By-Laws and Standard Operating Procedures of this Department.

Proposed Change: Add or his/her Designee.

A. The Chief or his/her Designee shall command the Department at all fires, drills or other Department activities, and shall enforce a strict performance of duty of the membership as described in the Constitution and By-Laws and Standard Operating

Procedures of this Department.

Levan made a motion to reject the revision as presented and Hughes seconded the motion. After discussion, the motion passed unanimously. Note: the Board proposed the change to read, A. "...the chief or his/her *authorized* Designee..."

- 4. Article IX. Duties of Officers Section 4. Special Command.
 - C. The Fire Marshal and the Public Information Officer shall serve as the public relations representative of the Department.

Proposed Change: Remove Fire Marshal.

Levan made a motion to approve the revision as presented and Katz seconded the motion. After discussion, the motion passed unanimously.

5. Article IX. Duties of Officers Section 7. Business Manager B.

Business Manager

- A. The Business Manager shall maintain all financial records of the Department
- B. The Business Manager shall give a monthly financial report to the Department including accounts received, total expenditure, and budget status.

Proposed Change: Change Monthly to Quarterly.

Revision: Change B. Chief or his/her designee shall

Hines made a motion to approve the revision as presented and Hughes seconded the motion. After discussion, the motion passed unanimously.

6. Article IX. Duties of Officers Section 10. Safety Officer.

Safety Officer

A. The Chief shall appoint a Safety Officer who shall be responsible for all safety related matters.

Proposed Change: Remove Safety Officer.

Hughes made a motion to approve the revision as presented and Levan seconded the motion. After discussion, the motion passed unanimously.

7. Article XI. Disciplinary Actions Section 4. Hearing procedures shall be as follows: E.

E. An appeal of the decision of the membership may be presented to the Board of Directors in writing within seven (7) days of that Business meeting. The decision of the Board is final.

Proposed Change: Remove Board of Directors and add department Secretary, add additional verbiage.

E. An appeal of the decision of the membership may be presented to the department Secretary in writing within seven (7) days of that Business meeting. The Secretary will form a committee of unbiased members to review the situation and make a ruling. The decision of the Committee is final.

Hughes made a motion to approve the revision as presented and Levan seconded the motion. After discussion, the motion passed unanimously.

Chief Woolley will be tasked with presenting the aforementioned edits/revisions to the Fire Department membership, at an upcoming membership meeting for their consideration.
